For cancellations received 60-30 days before departure 50% of the land and cruise price. For cancellations received 29-1 days before departure 80% of the land and cruise price. For cancellations received on departure day or later 100% of the land and cruise price. Additional fees will apply for any air tickets already issued. No refunds will be made for unused services once travel arrangements have commenced. If after returning from the cruise you wish to inquire about any cruise services provided, please ensure that all correspondence relating to those services is received by Amadeus Waterways within 60 days after the cruise completion.

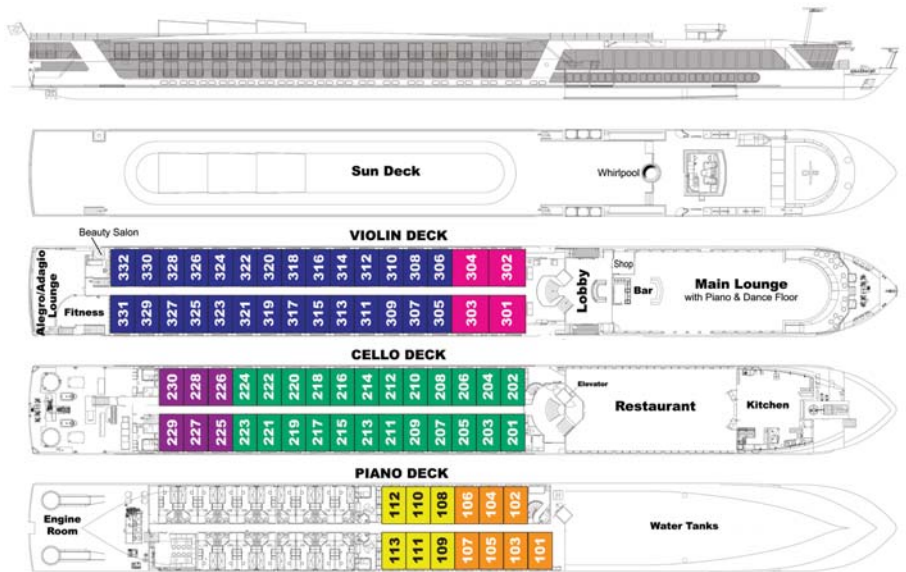
